Please be informed that the School's Annual Budget meeting took place on Saturday 20.10.2018. The Budget notification and the proposed budget and reminder notice was sent to all parents on 17.09.2018 and 16.10.2018 respectively. The following Resolutions were adopted at the meeting :

RESOLUTION 1 for 2019 SCHOOL FEE PROPOSAL

The proposed school fee for 2019 of R 4724 was rounded to R 4700.00 as presented in the financials details of the budget.

RESOLUTION 2 PAYMENT PLANS

The school fee referred to in PROPOSAL 1 may be paid in as follows :

OPTION 1 : If full school fee payment is made by 28 February 2019, a R 200 discount will be offered. You qualify to pay R 4500.00. (No increase from 2018 school fees).

OPTION 2 : If full school fee payment is made between 01 March 2019 and 30 April 2019, a R 100 discount will be offered. If the full school fee payment is made by 30 April 2019, you qualify to pay R 4600.00.

OPTION 3 : If any payment is made after 30 April 2019, the school fee remains at R 4700.00. No discounts will be offered.

RESOLUTION 3 : INCENTIVISING LEARNERS GR 8-11

The school will incentivise both learners and parents by offering a reduction in school fees payable in 2019 on a sliding scale (20%-100%) based on their overall performance as follows (subject to learner not being involved in any form of misconduct.)

- i. Gr 8-Gr 11(2018 learners) top 5 in the grade.
- ii. School fee exemption cases (where applicable: alternative incentives will be sourced eg : Stationery kit / Voucher – to same value should they be one of the above awardees)
