RESOLUTION 1: 2021 SCHOOL FEE RESOLUTION

The proposed school fee for 2021 of R 5124 be rounded to <u>R 5000</u>.00 as presented in the financial details of the budget.

RESOLUTION 2: PAYMENT PLANS

The school fee referred to in RESOLUTION 1 may be paid in as follows:

OPTION 1: If <u>full school fee payment is made by 31.03 2021</u>, <u>a</u> <u>R 200 discount</u> will be offered. You pay R 4800.00. (A decrease of R 100 from 2020 school fees .

OPTION 2: If <u>full school fee payment is made between 01 April 2021</u> and 30 June 2021, a R 100 discount will be offered. If the full school fee payment is made by 30 June 2021, you pay R 4900.00.

OPTION 3: If any payment is made <u>after 30 June 2021</u>, the school fee remains at <u>R 5000.00</u>. <u>No discounts</u> will be offered.
